



Botox Loyalty Program Agreement & Consent

Program Overview

The Texas Beauty NP Aesthetics & Wellness Botox Loyalty Program is designed to reward patients who maintain a consistent Botox treatment schedule. Program participants receive preferred pricing in exchange for maintaining regular treatment appointments as outlined below.

Participation in the Botox Loyalty Program is voluntary and subject to the terms and conditions listed in this agreement

Loyalty Program Terms and Conditions

1. Standard Pricing

The standard retail price for Botox treatments at Texas Beauty NP Aesthetics & Wellness is:

\$14.00 per unit

All patients enrolling in the Botox Loyalty Program will pay the standard retail price of **\$14.00 per unit for their initial treatment visit.**

2. Loyalty Program Pricing

After completion of the initial treatment visit, eligible participants who remain in compliance with all program requirements will receive Botox treatments at a discounted rate of:

\$11.50 per unit

The discounted loyalty pricing becomes effective beginning with the participant's **second qualifying treatment appointment.**

3. Required Appointment Schedule

To remain eligible for loyalty pricing, participants must:

- Maintain a scheduled Botox appointment approximately every three (3) months.
- Schedule and complete each follow-up treatment within ninety (90) days of the previous treatment date.
- Keep an active future appointment on the schedule before leaving the office whenever possible.

4. Limited Grace Period

Texas Beauty NP Aesthetics & Wellness understands that scheduling conflicts may occasionally occur.

A patient may reschedule a loyalty appointment up to **three (3) calendar days beyond the original due date** without losing loyalty program eligibility, provided the request is communicated to the office before the scheduled appointment time..

5. Loss of Loyalty Pricing

A participant will lose loyalty pricing and revert to standard pricing of **\$14.00 per unit** if any of the following occur:

- The follow-up appointment is scheduled more than three (3) days beyond the required treatment date.
- The participant fails to appear for a scheduled appointment.
- The participant cancels without sufficient notice as defined by office policy.
- The participant misses or skips a recommended treatment cycle.
- The participant voluntarily withdraws from the program.

If loyalty status is lost, the next Botox treatment will be charged at the standard rate of **\$14.00 per unit**.

Eligibility for discounted loyalty pricing may be reinstated only after completion of a subsequent treatment at the standard retail rate and continued compliance with all program requirements.

6. No Retroactive Discounts

Loyalty pricing:

- Is not retroactive.
- Cannot be applied to previous treatments.
- Cannot be combined with other promotional rates, special events, package pricing, or discounts unless specifically authorized in writing by Texas Beauty NP Aesthetics & Wellness.

7. Non-Transferability

Membership in the Botox Loyalty Program is:

- Personal to the enrolled patient.
- Non-transferable.
- Not redeemable for cash or credit.
- Not transferable to other individuals or family members.

8. Provider Discretion

Treatment recommendations, dosing requirements, and treatment intervals are determined solely by the treating Nurse Practitioner based on clinical assessment, safety considerations, and patient goals.

Participation in the Loyalty Program does not guarantee eligibility for treatment or a specific dosage.

9. Program Modifications

Texas Beauty NP Aesthetics & Wellness reserves the right to:

- Modify program requirements.
- Adjust pricing.
- Suspend or discontinue the program.

Any such changes will not affect services already rendered.

10. No Guarantee of Results

Botox results vary from patient to patient. Participation in the Loyalty Program does not guarantee specific aesthetic outcomes, duration of results, or treatment satisfaction.

By signing below, I acknowledge that:

- I have read and understand the Texas Beauty NP Aesthetics & Wellness Botox Loyalty Program Agreement.
- I understand that my initial treatment visit is charged at the standard rate of **\$14.00 per unit**.
- I understand that discounted loyalty pricing of **\$11.50 per unit** begins only after my initial treatment and only if I remain compliant with all program requirements.
- I understand that missed appointments, cancellations, scheduling delays, or failure to maintain treatment intervals may result in loss of loyalty pricing.
- I understand that Texas Beauty NP Aesthetics & Wellness reserves the right to determine eligibility and compliance with the program.
